Furthermore, I understand that the images or broadcast may be used in print publications, online publications, presentations, websites, and social media. I also understand that no royalty, fee, or other compensation shall become payable to me by reason of use.

WAIVER/RELEASE (Students under 18)

I understand the sports of gymnastics, dance, tumbling, parkour, etc. involve certain inherent risks, notwithstanding the safety precautions which are taken and I voluntarily agree to assume such risks on behalf of my child(ren). In consideration of your accepting my child(ren) as a student in your program, for myself, my heirs, my executors, administrators and assigns, I waive and release any and all rights and claims for damages I have against Elite Tumbling Academy QC, its sponsors, agents, employees, representatives, successors and assigns, (hereafter collectively termed ETA) for any and all injuries and losses suffered by my child(ren) and/or me and agree to indemnify and hold harmless ETA for any claims by me or my child(ren) arising out of participation in any program or otherwise at ETA or at any other location during an event sponsored by ETA. Additionally, I hereby grant ETA permission to render first aid emergency treatment which it considers necessary to my child(ren) while in attendance at ETA, or at any other location during an event sponsored by ETA and release all rights and claims for damages which said child(ren) or I may have against ETA in connection with the rendering of said first aid emergency treatment.

Furthermore, I also acknowledge the contagious nature of certain bacteria and viruses including, without limitation, COVID-19, and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by such bacteria or viruses by attending ETA and that such exposure or infection may result in personal injury, illness, permanent disability, or death. I understand that this PERPETUAL COVENANT NOT-TO-SUE will apply to EACH AND EVERY OCCASION that my child(ren) or I visit or participate at ETA and that this agreement remains in force until I revoke it in writing.

ATHLETE AND GUARDIAN AGREE TO ABIDE BY THE FOLLOWING GUIDELINES:

1. Athlete will NOT come to practice if they have a temperature or do not feel well in anyway. Athlete will be fever free for 48 hours with no medication prior to returning to gym.
2. Each athlete will be required to bring their own water bottle to drink. Water fountain is closed.
3. Students should arrive ready for class, avoid changing in restrooms, and bring only essential items into the building.
4. Guardians agree to discuss social distancing with your athlete prior to every practice, private lesson or class.
5. Correct hand washing or hand sanitizing will be done before and after each practice, private lesson or class.
6. Athletes will be dropped off and picked up at the proper gym (Tumbling gym or Cheer/Milltown gym)
7. Athlete will not arrive more than 5 minutes prior to class starting.
8. Parents will pick up promptly on time.
9. Proper social distancing practices will be adhered to at home.
10. If you feel like your child should wear PPE they need to provide their own.
